Steps to Take in Case Material Is Released or Spilled:

Wear complete and proper personal protective equipment following the recommendation of Section 8 at a minimum. Dike with suitable absorbent material like granulated clay. Gather and store in a sealed container pending a waste disposal evaluation. Shut off ignition sources; including electrical equipment and flames. Do not allow smoking in the area.

Wash thoroughly after handling. Avoid release to the environment. Wear protective gloves/protective clothing/eye protection/face protection. Handle and open container with care.

Storage: Keep container tightly closed. Store in a well-ventilated place. Keep cool. Store locked up. Store above 17 C (62.6 F)
